How to claim <u>Backdated Benefits and Reductions</u>

What is backdating Benefit?

Housing Benefit and Council Tax Support are normally awarded from the Monday following the day your application is received by the Benefit Service. However, the law allows us to make an award from an earlier date if you have a good reason (good cause) for not applying earlier.

For working age claims, we can only backdate your Housing Benefit for up to one month and your Council Tax Support for up to six months from the date you request this. You must give a good reason why this should be done.

What is good cause?

Some examples are:

- Death of a close relative.
- Being in hospital or seriously ill.
- Being wrongly advised by a person who should have known better, ie Council staff.

It is NOT good cause simply not applying.
