### **ROAD TRAFFIC REGULATION ACT 1984**

# THE BOROUGH OF STEVENAGE (STEVENAGE) (OFF-STREET PARKING PLACES) (AMENDMENT NUMBER ONE) ORDER 2023

The STEVENAGE BOROUGH COUNCIL (hereinafter referred to as "the Council") pursuant to arrangements made with the County Council of Hertfordshire under Section 19 of the Local Government Act 2000 and the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000, in exercise of the powers of the said County Council under Sections 32-35C, and Parts III and IV of Schedule 9, of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby makes the following Order:—

- 1. This Order may be cited as "The Borough of Stevenage (Stevenage) (Off-Street Parking Places) (Amendment Number One) Order 2023" and shall come into operation on 29 January 2024.
- 2. In this Order "the Principal Order" means The Borough of Stevenage (Stevenage) (Off-Street Parking Places) Order 2023.
- 3. The Principal Order is hereby amended as follows:
  - a) In the Preamble to the Principal Order, the word "Authorities" shall be substituted for the word "Government" in the phrase "the Local Government (Arrangements for the Discharge of Functions) (England) Regulations 2000".
  - b) In article 1. b) there shall be inserted between "TPE/03/22-9/06," and "inclusive" the words "TPE/03/22-9/07 and TPE/03/22-4/01".
  - c) In article 2. a) the words "it is" shall be substituted for the words "they are".
  - d) The schedule identified as "Schedule 1: The Borough of Stevenage (Railway North Car Park, Stevenage)(Off-Street Parking Places) Order Plans 2023" shall be replaced in its entirety by the following:
